- 2. Hawking 1 Budget Review-Brian Badillo, ExED
  - This year we are receiving Title 1 and Title 2 funds.
  - Title 1: ESSA: Every Student Succeeds Act. School wide Title 1 due to high number of Title 1 students this year. 76% of our students qualify. 75% is the minimum percentage needed to qualify
  - Title 2: Professional Development Funds for teacher trainings. Large increase in Title 2 funds as compared to last year.
  - Title 3: Part of ESSA. Funds must be used to support EL students. We are not receiving Title 3 funds this year. 2018-2019 school year and future we will be receiving these funds as well.
  - Federal funds we receive (Title 1,2,83) are small in comparison to general funds from ADA.
- 3. Facilities Update Kirti
  - After the EIR (Environmental Impact Report) showed a finding of methane gas in the ground of the building site, Turner Agassi made the strong recommendation that Hawking pull out of the land deal. The Chula Vista City Council is still in

support of our school but for the health of our students and faculty the decision was made not to fight for the location. We are back to square one and the search has begun again for new real estate. We are moving forward in looking at the possibility of a separate site for 6th, 7th, and 8th grade for the 2018-2019 school year. The priority for middle school is planning a high quality program.
